**Headnotes** Two of the most valuable features of LUBA’s website are the LUBA headnotes and search features. **The headnotes will give a summary of law concerning various issues, with citations to the case law. Reading the cases will then give a more detailed explanation, with further citations to statutes, goals, rules and cases.** The search feature makes it easy to find

the cases in the opinions feature (search case name). You can also search the cases back to 1990 using the key word search feature.

Its very important when building a case at the local level to try to base your arguments on state law (statutes, rules, or goals) if possible, to avoid “deference” problems with local interpretations of the local government’s own ordinances.
